

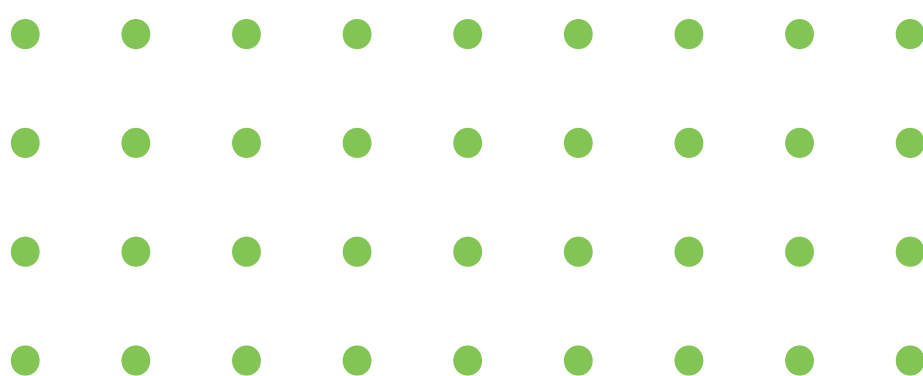

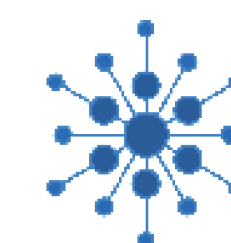
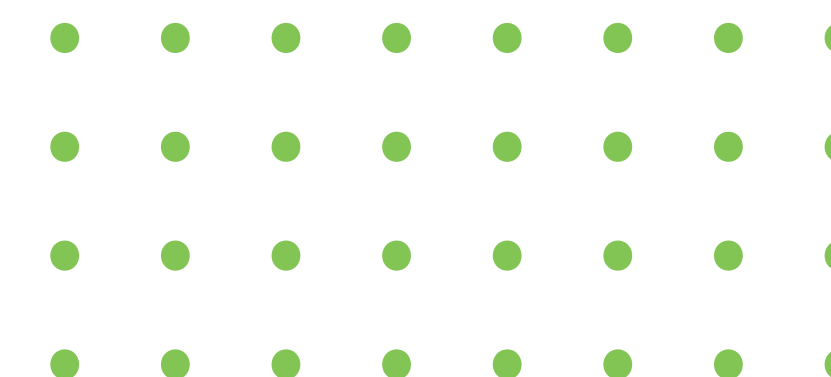

This year, the event will have the institutional partnership of the Weinstein International Foundation (WIF)*.

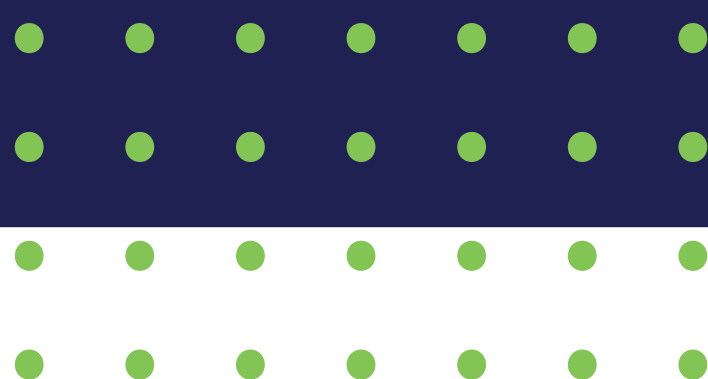
